



CONGRESSIONAL NOTIFICATIONS TRANSMITTAL SHEET

We wish to inform you of the intent of the Millennium Challenge Corporation (“MCC”) to discontinue any expenditures using Compact Implementation Funding as a distinct funding source in the Millennium Challenge Account compacts that MCC signed with Lesotho, Mongolia and Morocco and that have now entered into force.

For each compact, MCC plans to deobligate Compact Implementation Funding that will not be needed to accelerate implementation of the compact under section 609(g) of the Millennium Challenge Act of 2003, as amended (the “Act”), and plans to obligate the equivalent amount for the compact under section 605 of the Act. The funding is already included in the total amount of funding made available under the compact, and the change in funding authority will not increase that amount.

The attached notifications for Lesotho, Mongolia and Morocco are being sent to the Congress on February 24, 2008. Obligation of funds may be incurred on or after 15 days from the date of these notifications.

This notification is submitted pursuant to section 515 of the Foreign Operations, Export Financing, and Related Programs Appropriations Act, 2006 (Pub. L. 109-102), as carried forward by the Revised Continuing Appropriations Resolution, 2007 (Pub. L. 110-5). On July 23, 2007, the Millennium Challenge Corporation ("MCC") signed a Millennium Challenge Account compact (the "Compact") with the Government of the Kingdom of Lesotho, and at that time obligated \$15,668,416 to accelerate implementation of the Compact under the authority of section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act", 22 USC 7708(i)(1)) ("Compact Implementation Funding"). The Compact entered into force on September 17, 2008. The portion of Compact Implementation Funding, up to \$8,592,270, that is not needed to accelerate implementation of the Compact will now be deobligated and up to an equivalent amount of funding will now be obligated under section 605 of the Act. Such funding is already included in the total amount of funds made available under the Compact and will not increase total Compact funding.

This notification is submitted pursuant to section 515 of the Foreign Operations, Export Financing, and Related Programs Appropriations Act, 2006 (Pub. L. 109-102), as carried forward by the Revised Continuing Appropriations Resolution, 2007 (Pub. L. 110-5). On October 22, 2007, the Millennium Challenge Corporation ("MCC") signed a Millennium Challenge Account compact (the "Compact") with the Government of Mongolia, and at that time obligated \$5,022,683 to accelerate implementation of the Compact under the authority of section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act", 22 USC 7708(i)(1)) ("Compact Implementation Funding"). The Compact entered into force on September 17, 2008. The portion of Compact Implementation Funding, up to \$2,300,000, that is not needed to accelerate implementation of the Compact will now be deobligated and up to an equivalent amount of funding will now be obligated under section 605 of the Act. Such funding is already included in the total amount of funds made available under the Compact and will not increase total Compact funding.

This notification is submitted pursuant to section 515 of the Foreign Operations, Export Financing and Related Programs Appropriations Act, 2005 (Pub. L. 108-447, Division D). On August 31, 2007, the Millennium Challenge Corporation ("MCC") signed a Millennium Challenge Account compact (the "Compact") with the Government of the Kingdom of Morocco, and at that time obligated \$32,400,000 to accelerate implementation of the Compact under the authority of section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act", 22 USC 7708(i)(1)) ("Compact Implementation Funding"). The Compact entered into force on September 15, 2008. The portion of Compact Implementation Funding, up to \$28,700,000, that is not needed to accelerate implementation of the Compact will now be deobligated and up to an equivalent amount of funding will now be obligated under section 605 of the Act. Such funding is already included in the total amount of funds made available under the Compact and will not increase total Compact funding.
