

CONGRESSIONAL NOTIFICATIONS TRANSMITTAL SHEET

We wish to inform you of the intent of the Millennium Challenge Corporation ("MCC") to discontinue any expenditures using Compact Implementation Funding as a distinct funding source in the Millennium Challenge Account compacts that MCC signed with the Government of the Republic of El Salvador and the Government of the Republic of Mozambique and that have now entered into force.

For each compact, MCC plans to deobligate Compact Implementation Funding that will not be needed to accelerate implementation of the compact under section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act"), and plans to obligate the equivalent amount for the compact under section 605 of the Act. The funding is already included in the total amount of funding made available under the compact, and the change in funding authority will not increase that amount.

The attached notifications for El Salvador and Mozambique are being sent to the Congress on December 4, 2008. Obligation of funds may be incurred on or after 15 days from the date of these notifications.

OBLIGATION AMOUNT: \$5,200,000

This notification is submitted pursuant to section 515 of the Foreign Operations, Export Financing, and Related Programs Appropriations Act, 2006 (Pub. L. 109-102). On November 29, 2006, the Millennium Challenge Corporation ("MCC") signed a Millennium Challenge Account compact (the "Compact") with the Government of the Republic of El Salvador, and at that time obligated \$9,218,000 to accelerate implementation of the Compact under the authority of section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act", 22 USC 7708(i)(1)) ("Compact Implementation Funding"). The Compact entered into force on September 20, 2007. The portion of Compact Implementation Funding, up to \$5,200,000, that is not needed to accelerate implementation of the Compact will now be deobligated and up to an equivalent amount of funding will now be obligated under section 605 of the Act. Such funding is already included in the total amount of funds made available under the Compact and will not increase total Compact funding.

This notification is submitted pursuant to section 515 of the Foreign Operations, Export Financing, and Related Programs Appropriations Act, 2006 (Pub. L. 109-102), as carried forward by the Revised Continuing Appropriations Resolution, 2007 (Pub. L.110-5). On July 13, 2007, the Millennium Challenge Corporation ("MCC") signed a Millennium Challenge Account compact (the "Compact") with the Government of the Republic of Mozambique, and at that time obligated \$25,346,200 to accelerate implementation of the Compact under the authority of section 609(g) of the Millennium Challenge Act of 2003, as amended (the "Act", 22 USC 7708(i)(1)) ("Compact Implementation Funding"). The Compact entered into force on September 22, 2008. The portion of Compact Implementation Funding, up to \$22,000,000, that is not needed to accelerate implementation of the Compact will now be deobligated and up to an equivalent amount of funding will now be obligated under section 605 of the Act. Such funding is already included in the total amount of funds made available under the Compact and will not increase total Compact funding.
